# Team Athletes (Novice, Prep, Elite)

Families may cancel registration within 10 days of submitting their contract. Refund will be mins a \$50 administrative fee. To cancel, please provide written notice via email to info@coastalwaveelite.com.

After this period, all fees paid are non-refundable and cannot be credited or transferred. HST is applicable to all listed fees.

By submitting the Coastal Wave Elite 2025–2026 Allstar Team Registration Form, you agree to the following terms:

1. Your registration fee, if unpaid, will be processed within 48 hours of submitting your form.

2. Monthly tuition payments will be processed on the 1st of each month from June 1, 2025 to April 1, 2026.

3. All star fees will be processed with tuition on the 1st of the month July through December or for the 6 months after joining if joining late

4. Athletes accepting an offer for the 2025–2026 season are responsible for:

- a) Registration Fee,
- b) Monthly Tuition,
- c) All Star Fees
- d) Additional Travel Fees
- e) Uniform

f) Cheer NL and Cheer Canada Membership Fees (paid directly to those organizations).

5. Tuition represents a full-season commitment and is divided into equal monthly installments for convenience. All holidays and scheduled closures have already been considered in the overall pricing. Please note that each installment is not tied to a specific month or period of service. For example, a payment made on February 1, 2025, is not a payment for February's training—it is one part of the total season tuition.

6. Uniform costs are not included in tuition. All orders must be placed through the CWE Pro Shop by the stated deadline and are final sale—no refunds, credits, or exchanges.

7. To withdraw, 30 days' written notice must be submitted to info@coastalwaveelite.com. Any scheduled payments during this notice period remain due. No refunds or prorated credits will be issued. All fees paid are non-refundable. For example, if a family provides written notice requesting their athlete be removed from an Allstar team on November 20th, 2025, they are required to make all scheduled payments until December 19th, 2025 (including, but not limited to tuition fees, competition fees, etc.). These scheduled fees are not eligible for pro-ration, transfer or a credit of any kind.

8. If any part of this agreement is found to be invalid or unenforceable, the remainder shall continue in full effect.

### **Recreational Class Athletes**

Recreational class membership is a recurring membership and is billed on the 1st of each month. Written notice is required to withdraw. Notice must be received before the end of the month.

Any payments withdrawn are non-refundable. I.e., if you request to withdraw on the 2nd of the month, that month's tuition is non-refundable. You will be able to continue attending the classes for which you have paid.

#### **Private Lesson Athletes**

Private lesson membership is a recurring membership and is billed on the 1st of each month. Written notice is required to withdraw. Notice must be received before the end of the month.

Any payments withdrawn are non-refundable. I.e., if you request to withdraw on the 2nd of the month, that month's tuition is non-refundable. You will be able to continue attending the classes for which you have paid.

### **General Payment Terms**

Accepted payment methods include Visa, Mastercard, or direct deposit from a chequing account. Your preferred payment method must be provided at the time of registration.

A failed payment attempt on the 1st of any month will be tried again on the 3rd of the month. Accounts will be flagged as past due if there is an outstanding balance on the 3rd day of the month. Accounts must be in good standing at all times. Any athlete whose account is not in good standing will not be permitted to practice or train. Coastal Wave Elite has taken great care to structure this season's fees in a manner that eases financial strain on our families by spacing tuition fees as evenly as possible throughout the season and pushing additional fees until right before they are used. All fees paid are non-refundable.

Any declined payments will incur a \$50 NSF fee.

Prep/Elite Team Athlete Attendance Policy - Attendance at practices and scheduled events is mandatory for all team athletes. Athletes with more than three absences from September 2025 to May 2026 will be charged \$25 + HST per additional absence. Charges will be processed the following month via your payment method on file.
